

Brooks Adrenaline GTS 25 Anniversary Challenge Sweepstakes Official Rules

Important: Please read these rules before participating in the Sweepstakes (defined below). By participating in this Sweepstakes, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility: Brooks Adrenaline GTS 25 Anniversary Challenge Sweepstakes (the “Sweepstakes”) is open only to legal residents of the fifty (50) United States (including the District of Columbia) and Canada (excluding Quebec) who are at least eighteen (18) years old at the time of entry. Employees of Brooks Sports, Inc. (“Sponsor”), Merkle Inc. (“Administrator”), Strava, Inc., and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, provincial, municipal, territorial, and local laws and regulations and is void in Quebec and where prohibited. Participation constitutes entrant’s full and unconditional agreement to these Official Rules. Sponsor’s and Administrator’s decisions are final and binding in all matters related to the Sweepstakes. Timing: The Sweepstakes begins on November 1, 2025 at 12:00 a.m. Eastern Time (“ET”) and ends on December 13, 2025 at 11:59 p.m. ET (the “Sweepstakes Period”).

Administrator’s computer is the official time-keeping device for the Sweepstakes.

How to Enter the Sweepstakes: There are two (2) Sweepstakes prize pools (each a “Prize Pool”) to award the Adrenaline GTS 25 Shoe Prizes (“First Prize” drawings). Legal residents of the fifty (50) United States (including the District of Columbia) will comprise the U.S. Prize Pool and legal residents of Canada (excluding Quebec) will comprise the Canada Prize Pool. In addition, there is one (1) Grand Prize drawing that will include both Prize Pools (“Grand Prize” drawing).

During the Sweepstakes Period, there are two (2) ways to enter the Sweepstakes, as outlined below:

Complete the Brooks Adrenaline GTS 25 Anniversary Challenge in Strava App: During the Promotion Period, download the Strava mobile app (“App”), to your mobile device, if you haven’t already done so. Then, follow the links and instructions to complete and track 25 Miles (not consecutively) within the App (“Challenge”). Once complete, you will receive an email to the email address associated with the App. Either click on the link included in the email or simply visit the <https://brooks.promo.eprize.com/adrenalinegts25challenge2025/>. During the Promotion Period, follow the links and instructions to complete and submit the registration form, including a valid email address. You will receive one (1) Sweepstakes entry into the applicable Prize Pool drawing and one (1) Sweepstakes entry into the Grand Prize drawing.

Please consult your doctor before engaging in any exercise or training activity. If you experience a medical emergency, please stop your exercise or training activity and consult with a medical professional immediately.

Message and data rates apply to use of mobile device. You may be charged by your wireless carrier for participating via mobile device. Alternate Method of Entry: During the Promotion Period, to enter without downloading the App or tracking the Challenge, print your name, address, day and evening phone numbers, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to the address below.

You will receive one (1) Sweepstakes entry into the applicable Prize Pool drawing and one (1) Sweepstakes entry into the Grand Prize drawing. Limit: One (1) entry per envelope. All mail-in entries must be handwritten and must be postmarked by December 15, 2025 and received by December 22, 2025. Limit All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected, or postage-due entries, which will be disqualified.

Limit: You may enter one (1) time during the Promotion Period, regardless of method of entry. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and may result in disqualification. In the event of a dispute as to the identity of an entrant, Sponsor and Administrator will rely on the information submitted by the entrant to register for this Sweepstakes. If any additional information provided by entrant is inconsistent with the information provided at registration for this Sweepstakes, Sponsor and/or Administrator may disqualify such entrant and such disqualification may result in the forfeiture of any prizes won. Sponsor, in its discretion, may require additional documentation from entrant to show proof of entrant's identity.

Prize Drawings: Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. Administrator will randomly select the potential Sweepstakes First Prize winners from all eligible entries received for each respective Prize Pool and the Sweepstakes Grand Prize winner from all eligible entries received during the Promotion Period on or around January 5, 2026. The potential winners will be notified by email. Potential winners may be required to provide their name, home mailing address (P.O. Boxes may not be permitted), and date of birth to confirm eligibility and for purposes of prize fulfillment within five (5) days of the date notice or attempted notice is sent, in order to claim the prize. If a Canadian resident, the potential winner will be required to correctly answer a time-limited skill testing question without any assistance in order to be eligible to receive a prize. If the potential winner is a Canadian resident and the question is answered incorrectly, the prize will be forfeited. If potential winner is a Canadian resident, they will be required to complete IRS Form W-8BEN. The potential Grand Prize winner (or parent/legal guardian if winner is a minor in their place of residence) will be required to sign and return a Declaration of Compliance, Liability Waiver and where not prohibited a Publicity Release ("Declaration") which must be received by Administrator within five (5) days of the date notice or attempted notice is sent, in order to claim the prize. If a potential winner of any prize cannot be contacted, fails to return the Declaration or provide any

requested information within the required time period (if applicable), or the prize is returned as undeliverable, the potential winner forfeits the prize. Receiving a prize is contingent upon compliance with these Official Rules. In the event that a potential winner is disqualified for any reason or forfeits the prize, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded.

Sweepstakes Prizes, Approximate Retail Value (“ARV”), and Odds of Winning:

Prizes: ONE (1) GRAND PRIZE: A \$2,500 check. ARV: \$2,500.00 USD.

ONE HUNDRED (100) FIRST PRIZES (eighty (80) awarded to the U.S. Prize Pool and twenty (20) awarded to the Canada Prize Pool): A pair of Adrenaline GTS 25 shoes. ARV: \$155.00 USD.

For All Prizes: Prizes are non-transferable, and no substitution will be made except as provided herein at the Sponsor’s sole discretion. Prize style, size, and all other details will be determined by Sponsor in its sole discretion. Sponsor reserves the right to substitute a prize for one of equal or greater value, if the designated prize should become unavailable for any reason, including but not limited to substitute a shoe due to the unavailability of an applicable style or size. Winners are responsible for all taxes and fees associated with prize receipt and/or use. The odds of winning the Grand Prize depend on the total number of eligible entries received during the Promotion Period. The odds of winning a First Prize depend number of eligible entries received for the applicable Prize Pool. Limit: one (1) prize per person. Prizes will be fulfilled approximately 8-10 weeks after conclusion of the Sweepstakes. Total ARV of U.S. Prize Pool Prizes: \$14,900.00 USD. Total ARV of Canada Prize Pool Prizes: \$5,600.00 USD.

For Canadian Winners: If winner is a resident of Canada, Sponsor will gross up the prize value in an amount to satisfy the 30% withholding requirement. The withholding amount will be submitted to the US taxing authority IRS (the United States tax agency) as required by law and winner will receive a U.S tax form 1042 from the Administrator reflecting the total value of the prize, including the gross up amount and the withholding amount submitted to the IRS will be noted separately.

ON BEHALF OF YOU AND YOUR ASSIGNS, HEIRS, DEVISEES AND ESTATE (COLLECTIVELY, "SUCCESSORS"), YOU HEREBY UNCONDITIONALLY AND FOREVER RELEASE, DISCHARGE AND AGREE TO INDEMNIFY AND HOLD HARMLESS SPONSOR, ADMINISTRATOR, AND OTHER PROVIDERS OF THE SWEEPSTAKES, OR ANY PORTION THEREOF, AND EACH OF THEIR RESPECTIVE PARENT COMPANIES, SUBSIDIARIES, AFFILIATES, OFFICERS, DIRECTORS, EMPLOYEES, AGENTS, PROFESSIONAL ADVISORS, CONTRACTORS, AND ADVERTISING/MARKETING AND PROMOTION AGENCIES (COLLECTIVELY, "RELEASED PARTIES"), FROM ANY AND ALL CLAIMS, JUDGMENTS, COSTS, DAMAGES, LOSSES, EXPENSES AND LIABILITIES (WHETHER UNDER CONTRACT, WARRANTY, TORT (INCLUDING

NEGLIGENCE (WHETHER ACTIVE, PASSIVE OR IMPUTED), STRICT LIABILITY, PRODUCT LIABILITY OR ANY OTHER THEORY)) RELATING TO ANY CLAIM YOU MAY NOW OR LATER HAVE WITH RESPECT TO ANY DEATH, PERSONAL INJURY, PROPERTY DAMAGE, PECUNIARY OR OTHER LOSS, DAMAGE, COST OR EXPENSE (COLLECTIVELY, "HARM") THAT MAY BE SUFFERED BY YOU OR ANY THIRD PARTY AS A RESULT OF, AND/OR IN CONNECTION WITH, THE SWEEPSTAKES, EVEN IF SUCH HARM IS CAUSED SOLELY BY THE RECKLESSNESS, NEGLIGENCE OR FAULT OF ONE OR MORE RELEASED PARTIES (COLLECTIVELY, THE "RELEASED CLAIMS"). YOU UNDERSTAND AND AGREE THAT THIS RELEASE WILL PREVENT YOU AND YOUR SUCCESSORS FROM BRINGING ANY ACTION AGAINST ANY RELEASED PARTY AND FROM RECOVERING ANY MONEY DAMAGES OR OTHER RELIEF FROM ANY RELEASED PARTY IN CONNECTION WITH ANY OF THE RELEASED CLAIMS.

If any provision of these Official Rules is found to be unenforceable in any respect by a court of competent jurisdiction, you agree that it is your intent and understanding that these Official Rules will nonetheless be enforced to the maximum extent to which it is found to be legally enforceable. TO THE EXTENT PERMITTED BY LAW, YOU WAIVE THE BENEFIT OF ANY PROVISIONS OF ANY STATUTE OR OTHER LAW THAT MIGHT ADVERSELY AFFECT THE RIGHTS OF ANY RELEASED PARTY UNDER THIS AGREEMENT.

Without limiting the foregoing, to the maximum extent permitted by law, you waive all rights you may have under California Civil Code Section 1542, which reads as follows:

"A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the Release, which if known by him must have materially affected the settlement with the debtor."
