Brooks x Strava: Best Efforts Challenge Giveaway Official Rules

Administrator's computer is the official time-keeping device for the Sweepstakes.

Complete the Brooks Best Efforts Challenge (for 13.1 miles, a half-marathon) in Strava App: During the Promotion Period, download the Strava mobile app ("App"), to your mobile device, if you haven't already done so. Then, follow the links and instructions to complete a new challenge: obtaining a new personal record ("PR") during a half-marathon run (13.1 miles), and track within the App. Once complete, you will receive an email to the email address associated with the App. Either click on the link included in the email or simply visit https://brooks.promo.eprize.com/besteffortschallenge2025/ ("Promotion Site"). During the Promotion Period, follow the links and instructions to complete and submit the registration form, including a valid email address. You will receive one (1) Sweepstakes entry into the applicable Prize Pool drawing.

Please consult your doctor before engaging in any exercise or training activity. If you experience a medical emergency, please stop your exercise or training activity and consult with a medical professional immediately.

Message and data rates apply to use of mobile device. You may be charged by your wireless carrier for participating via mobile device. It is therefore recommended that you consult your

b. Alternate Method of Entry: During the Promotion Period, to enter without downloading the App or obtaining a PR, print your name, address, day and evening phone numbers, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to the address below.

You will receive one (1) Sweepstakes entry into the applicable Prize Pool drawing. <u>Limit</u>: One (1) entry per envelope. All mail-in entries must be handwritten and must be postmarked by April 29, 2025 and received by May 6, 2025. <u>Limit</u> All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected, or postage-due entries, which will be disqualified.

<u>Limit</u>: You may enter one (1) time during the Promotion Period, regardless of method of entry. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. In the event of a dispute as to the identity of an entrant, Sponsor and Administrator will rely on the information submitted by the entrant to register for this Sweepstakes. <u>For All Prizes</u>: Prizes are non-transferable, and no substitution will be made except as provided herein at the Sponsor's sole discretion. Prize style, size, and all other details will be determined by Sponsor in its sole discretion. Sponsor reserves the right to substitute a prize for one of equal or greater value, if the designated prize should become unavailable for any reason, including but not limited to substitute a shoe due to the unavailability of an applicable style or size. Winners are responsible for all taxes and fees associated with prize receipt and/or use. The odds of winning a prize depend on the total number of eligible entries received during the Promotion Period. <u>Limit</u>: one (1) prize per person. If any provision of these Official Rules is found to be unenforceable in any respect by a court of competent jurisdiction, you agree that it is your intent and understanding that these Official Rules will nonetheless be enforced to the maximum extent to which it is found to be legally enforceable.
