

Brooks Run Club Magic Milestone Sweepstakes 2026

Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility:

Brooks Run Club Magic Milestone Sweepstakes 2026 (the "Sweepstakes") is open only to legal residents of the 50 United States (including District of Columbia) who (i) are at least 18 years old and (ii) are Brooks Run Club* members at the time of entry. To receive a prize valued at \$2,000 or more, entrant must be able to submit a valid IRS Form W-9. Brooks Friends and Family discount holders, Sports Medicine Ambassadors, and employees of Brooks Sports, Inc. ("Sponsor"), Disney Worldwide Services, Inc. ("Disney"), Merkle Inc. ("Administrator"), PWR Lab, Inc d.b.a. DashLX, and their parent and affiliate companies, suppliers as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible.

Agreement to Official Rules; Entrants Will Be Disqualified for Violations:

Participation constitutes each entrant's full and unconditional agreement to these official rules ("Official Rules"). The Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Timing:

The Sweepstakes begins on September 2, 2026 at 12:00 a.m. Eastern Time ("ET") and ends on October 31, 2026 at 11:59 p.m. ET (the "Promotion Period"). Administrator's servers are the official time-keeping devices for the Sweepstakes.

How to Enter:

*All entrants must join the Brooks Run Club membership program ("Program") to participate, if not already enrolled. The Program is free to join on BrooksRunning.com.

Important: Please review your Brooks Run Club membership profile to ensure that it is complete and includes your real name and email address. Inaccurate information could impact your ability to win a prize.

Create a BrooksRunning.com Account or Log into your existing Account:

During the Promotion Period, visit https://www.brooksrunning.com/en_us/brooks-run-club-magic-milestone-sweepstakes ("Promotion Site") and either complete and submit the form to create a BrooksRunning.com account ("Account") or simply login to your existing Account. Next, follow the links and instructions to complete and submit the registration form including your gear preference, date of birth, and ZIP Code. Then, you may earn Sweepstakes entries, as outlined below:

Method 1 –Participate in the Milestone Challenges:

During the Promotion Period, follow the instructions on the Promotion Site to complete the milestone challenges (each a "Milestone Challenge") and track with your device to receive the number of Sweepstakes entries indicated below.

Method 2 – Mail-in Alternate Method of Entry:

To enter without completing the Milestone Challenges outlined above, print your name, address, phone number, email address associated with your Account, and date of birth on a piece of paper and mail it in an envelope with proper postage to "Brooks Run Club Magic Milestone Sweepstakes 2026," c/o Merkle Inc., P.O. Box 5008, Department 869586, Kalamazoo, MI 49003-5008. **You must list the Milestone Challenge (as outlined in the above table) on the outside of the envelope.** You will receive the specified number of Sweepstakes entries for the applicable Milestone Challenge as outlined in the above table. **NOTE: If you do not include the Milestone Challenge written on the outside of the envelope, you will not receive the designated amount of Sweepstakes entries.** Limit: 1 entry request per envelope. Multiple entrants are not permitted to share the same email address or Account. In the event of a dispute as to the identity of an entrant, Sponsor and Administrator will rely on the information submitted by the entrant to register for the Brooks Run Club membership. If any additional information provided by entrant is inconsistent with the information provided in the Brooks Run Club profile, Sponsor and/or Administrator may disqualify such entrant and such disqualification may result in the forfeiture of any prizes won. Sponsor, in its discretion, may require additional documentation from entrant to show proof of entrant's identity.

Prize Drawing and Winner Requirements:

Administrator is an independent organization whose decisions as to the selection of the potential winners are final and binding. Administrator will randomly select the potential Sweepstakes winners from all eligible entries received during the Promotion Period, on or around November 13, 2026 and will notify potential winners by email. Total ARV:

Without limiting the foregoing, to the maximum extent permitted by law, you waive all rights you may have under California Civil Code Section 1542, which reads as follows:

"A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the Release, which if known by him must have materially affected the settlement with the debtor."

General Conditions:

Sponsor's Right to Modify or Cancel:

If any provision of these Terms shall be deemed unlawful, void or for any reason unenforceable, then that provision shall be deemed severable from these Terms and shall not affect the validity and enforceability of any remaining provisions.
