

Brooks Run Club Trivia Game

Official Rules

Important: Please read these rules before participating in the Instant Win Game (defined below). By participating in this Instant Win Game, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Brooks Run Club Trivia Game (the "Instant Win Game") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees, officers, and representatives of Brooks Sports, Inc., Merkle Inc., as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible.
