Brooks Run Club Official Rules

Important: Please read these rules before participating in the Sweepstakes and/or Program (each defined below). By participating in this Sweepstakes and/or Program, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

YOU UNDERSTAND AND AGREE THAT THIS RELEASE WILL PREVENT YOU AND YOUR SUCCESSORS FROM BRINGING ANY ACTION AGAINST ANY RELEASED PARTY AND FROM RECOVERING ANY MONEY DAMAGES OR OTHER RELIEF FROM ANY RELEASED PARTY IN CONNECTION WITH ANY OF THE RELEASED CLAIMS.

If any provision of these Program Rules is found to be unenforceable in any respect by a court of competent jurisdiction, you agree that it is your intent and understanding that these Program Rules will nonetheless be enforced to the maximum extent to which it is found to be legally enforceable.
