

Ghost Amp Challenge Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Overview:

The Ghost Amp Challenge (the “Sweepstakes”) consists of a grand prize sweepstakes (the “Grand Prize Sweepstakes”, available during the entire Promotion Period (as defined below) and a ghost amp sweepstakes (the “Ghost Amp Sweepstakes”) available for 15 days of the Promotion Period (see Timing Section for start and end date). For the Grand Prize Sweepstakes, Sponsor will award 2 Grand Prizes. For the Ghost Amp Sweepstakes, Sponsor will award 30 Amp Days Milestone Prizes.

Eligibility:

The Grand Prize Sweepstakes and Ghost Amp Sweepstakes are open only to legal residents of the 50 United States (including District of Columbia) who are at least 18 years old and are a Brooks Run Club* member at the time of entry. To receive a Grand Prize, entrant must be able to submit a valid IRS Form W-9. Brooks Friends and Family discount holders, Sports Medicine Ambassadors, and Employees of Brooks Sports, Inc. (“Sponsor”), Merkle Inc. (“Administrator”), PWR Lab, Inc d.b.a. DashLX, and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible.

Agreement to Official Rules; Entrants Will Be Disqualified for Violations:

Participation constitutes each entrant’s full and unconditional agreement to these official rules (“Official Rules”). The Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Sponsor’s and Administrator’s decisions are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all the requirements set forth herein.

Timing:

The Sweepstakes begins on August 3, 2026 at 12:00 a.m. Eastern Time ("ET") and ends on August 31, 2026 at 11:59 p.m. (the "Promotion Period"). The Ghost Amp Sweepstakes begins August 17, 2026 at 12:00 a.m. ET and ends on August 31, 2026 at 11:59 p.m. ET ("Ghost Amp Sweepstakes Period").

Administrator's servers are the official time-keeping devices for the Sweepstakes.

How to Enter and Earn Grand Prize Sweepstakes and Ghost Amp Sweepstakes

Entries:

*All entrants must join the Brooks Run Club membership program ("Program") to participate, if not already enrolled. The Program is free to join on BrooksRunning.com.

Create a BrooksRunning.com Account or Log into your existing Account:

During the Promotion Period, visit the "[Promotion Site](#)" and either complete and submit the form to create a BrooksRunning.com account ("Account") or simply login to your existing Account. Next, follow the links and instructions to complete and submit the registration form including your gear preference, date of birth, and zip code.

Important: Please review your Brooks Run Club membership profile to ensure that it is complete and includes your real name and email address. Inaccurate information could impact your ability to win a prize.

Method 1 - Sync your Device and Log 1 Run/Walk Activity:

Follow the instructions on the Promotion Site to sync your device ("Device") with Brooks' run data partner, DashLX. To do so, click on the "Sync now" button link via the Promotion Site to visit <https://app.dashlx.com/optin/brooks-run-club>.

By syncing your Device, you will receive 10 entries into the Grand Prize Sweepstakes drawing. **Limit:** Each entrant may complete this action 1 time during the Promotion Period.

By logging your **first** run or walk activity (any activity), you will receive 10 entries into the Grand Prize Sweepstakes drawing. **Limit:** Each entrant may complete this action 1 time during the Promotion Period.

Once you Sync your Device and Log 1 Run/Walk Activity, you may then Participate in the milestone challenges (“Milestone Challenges”) or you may participate in Method 2. You must complete the above in order to participate in any of the Milestone Challenges.

There are additional ways to earn Sweepstakes entries into the Grand Prize Sweepstakes and Ghost Amp Sweepstakes, as outlined below. Once you complete the following run/walk Milestone Challenges and track with your Device, you will receive the number of Sweepstakes entries indicated below.

Method 2 - Mail-in Alternate Method of Entry:

To earn Sweepstakes entries without syncing a Device, logging any activity, and participating in a Milestone Challenge, print your name, address, phone number, the email address associated with your Account, and your date of birth on a piece of paper and mail it in an envelope with proper postage to "Ghost Amp Challenge," c/o Merkle Inc., P.O. Box 5008, Department 869438, Kalamazoo, MI 49003-5008. You will receive 120 Sweepstakes entries into the Grand Prize Sweepstakes drawing and 1 Sweepstakes entry into the Ghost Amp Sweepstakes drawing. All mail-in entries must be sent/postmarked by August 31, 2026 and received by September 8, 2026. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

Entry Limits:

You may receive up to 120 Sweepstakes entries into the Grand Prize Sweepstakes during the Promotion Period and 1 Sweepstakes entry into the Ghost Amp Sweepstakes drawing during the Ghost Amp Sweepstakes Period by either participating in Method 1 or Method 2, as outlined above. Multiple entrants are not permitted to share the same email address or Account. In the event of a dispute as to the identity of an entrant, Sponsor and Administrator will rely on the information submitted by the entrant to register for the Brooks Run Club membership. If any additional information provided by entrant is inconsistent with the information provided in the Brooks Run Club profile, Sponsor and/or Administrator may disqualify such entrant and such disqualification may result in the forfeiture of any prizes won. Sponsor, in its discretion, may require additional documentation from entrant to show proof of entrant's identity.

Prize Drawings and Winner Requirements:

Grand Prize Sweepstakes: Administrator will randomly select each potential Sweepstakes Grand Prize winner from all eligible entries on or around September 15, 2026.

Ghost Amp Sweepstakes: Administrator will randomly select the potential 30 Ghost Amp Sweepstakes winners from all eligible entries on or around September 15, 2026.

Administrator is an independent organization whose decisions as to the selection of the potential winners are final and binding. The potential winners will be notified by email. Potential Grand Prize winners (or parent/legal guardian if winner is a minor in their state of residence) will be required to sign and return a Declaration of Compliance, Liability Waiver and where not prohibited a Publicity Release ("Declaration") and an IRS Form W-9 which must be received by Administrator within 5 days of the date notice or attempted notice is sent, in order to claim the prize. RESPECTIVE PARENT COMPANIES, SUBSIDIARIES, AFFILIATES, OFFICERS, DIRECTORS, EMPLOYEES, AGENTS, PROFESSIONAL ADVISORS, CONTRACTORS, AND ADVERTISING/MARKETING AND PROMOTION AGENCIES (COLLECTIVELY, "RELEASED PARTIES"), FROM ANY AND ALL CLAIMS, JUDGMENTS, COSTS, DAMAGES, LOSSES, EXPENSES AND LIABILITIES (WHETHER UNDER CONTRACT, WARRANTY, TORT (INCLUDING NEGLIGENCE (WHETHER ACTIVE, PASSIVE OR IMPUTED), STRICT LIABILITY, PRODUCT LIABILITY OR ANY OTHER THEORY)) RELATING TO ANY CLAIM YOU MAY NOW OR LATER HAVE WITH RESPECT TO ANY DEATH, PERSONAL INJURY, PROPERTY DAMAGE, PECUNIARY OR OTHER LOSS, DAMAGE, COST OR EXPENSE (COLLECTIVELY, "HARM") THAT MAY BE SUFFERED BY YOU OR ANY THIRD PARTY AS A RESULT OF, AND/OR IN CONNECTION WITH, THE SWEEPSTAKES, EVEN IF SUCH HARM IS CAUSED SOLELY BY THE RECKLESSNESS, NEGLIGENCE OR FAULT OF ONE OR MORE RELEASED PARTIES (COLLECTIVELY, THE "RELEASED CLAIMS"). YOU UNDERSTAND AND AGREE THAT THIS RELEASE WILL PREVENT YOU AND YOUR SUCCESSORS FROM BRINGING ANY ACTION AGAINST ANY RELEASED PARTY AND FROM RECOVERING ANY MONEY DAMAGES OR OTHER RELIEF FROM ANY RELEASED PARTY IN CONNECTION WITH ANY OF THE RELEASED CLAIMS.

If any provision of these Official Rules is found to be unenforceable in any respect by a court of competent jurisdiction, you agree that it is your intent and understanding that these Official Rules will nonetheless be enforced to the maximum extent to which it is found to be legally enforceable. TO THE EXTENT PERMITTED BY LAW, YOU WAIVE THE BENEFIT OF ANY PROVISIONS OF ANY STATUTE OR OTHER LAW THAT MIGHT ADVERSELY AFFECT THE RIGHTS OF ANY RELEASED PARTY UNDER THIS AGREEMENT.

Without limiting the foregoing, to the maximum extent permitted by law, you waive all rights you may have under California Civil Code Section 1542, which reads as follows:

"A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the Release, which if known by him must have materially affected the settlement with the debtor."

By receipt of any prize, winner agrees to release and hold harmless the Released Parties from and against any losses, damages, rights, claim, or cause of action of any kind arising, in whole or in part, directly or indirectly, out of participation in the Sweepstakes or resulting directly or indirectly, from acceptance, possession, use, or misuse of any prize awarded in connection with the Sweepstakes, including without limitation personal injury, death, and/or property damage, as well as claims based on publicity rights, defamation, and/or invasion of privacy.

General Conditions:

Sponsor's Right to Modify or Cancel:

Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, including but not limited to fulfillment of the prize(s), where any of the following "Issues" occur:

- Fraud;
- Technical failures;
- Human error;
- Any other factor that impairs the integrity or proper functioning of the Sweepstakes; or
- Any event or cause beyond Sponsor's control (e.g. events such as natural calamities, national emergencies, widespread illnesses, declarations of war, acts of God, acts of terrorism) that interferes with any aspect of the Sweepstakes, as determined by Sponsor in its sole discretion.
- Where one or more of the above Issues occurs, Sponsor will make reasonable efforts to award all remaining Sweepstakes prizes by conducting a random drawing from among all eligible entries received up to the date of the Issue; and/or modify the prizes offered.

Sponsor's Right to Disqualify Entrants:

Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes, including but not limited to submitting fraudulent entries, or to be acting in violation of the Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a

violation of criminal and civil law and should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Sponsor's Right to Limit Prizes Awarded to the Number Stated in these Official Rules:

In no event will more prizes than are stated in these Official Rules be awarded. If, for any reason, more prize notifications are sent than the number of prizes offered in these Official Rules, Administrator and Sponsor reserves the right to award only the stated number of prizes through a random drawing from among those entrants who were notified, confirmed to be eligible and where applicable, took the required action(s) to claim the prize.

Limitations of the Scope of Responsibility:

The Released Parties are not responsible for:

- Any incorrect or inaccurate information either provided by entrants or caused by printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes;
- Technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections to the internet, social media platforms, in phone lines or network hardware or software;

Disputes:

All disputes will be resolved as set forth in the Sponsor's [Terms of Use](#), including the mandatory arbitration provision. ARBITRATION PREVENTS YOU FROM SUING IN COURT OR FROM HAVING A JURY TRIAL. Whether the dispute is heard in arbitration or in court, neither you nor Brooks will commence against each other a class action, class arbitration or other representative action or proceeding.

Severability:

If the application of any provision of these Official Rules to any particular facts or circumstances shall for any reason be held to be invalid, illegal or unenforceable by a court, arbitration panel or other tribunal of competent jurisdiction, then:

- The validity, legality and enforceability of such provision as applied to any other particular facts or circumstances and the other provisions of these Official Rules shall not in any way be affected or impaired thereby; and
- Such provision shall be enforced to the maximum extent possible.

In addition, if any provision contained in these Official Rules shall for any reason be held to be excessively broad as to duration, geographical scope, activity or subject, it shall be construed by limiting and reducing it so as to be enforceable to the extent compatible with applicable law.
