## Brooks Run Club 2024 Seattle Adventure Extravaganza Official Rules

Important: Please read these rules before participating in the Promotion (defined below). By participating in this Promotion, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

Next, follow the links and instructions to complete and submit the registration form including your gear preference, date of birth, and zip code.

Then, during the Promotion Period, there are various ways to earn Sweepstakes entries, as outlined below:

a. Sync your Device: Follow the instructions on the Website to sync your device with Brooks' run data partner, DashLX. To do so, click on the "Get started now" button or the "Link your fitness tracker to play now" link via the Website to visit <a href="https://app.dashlx.com/optin/brooks-run-club">https://app.dashlx.com/optin/brooks-run-club</a>. You will receive ten (10) entries into the Sweepstakes. <a href="Limit">Limit</a>: Each entrant may

complete this action one (1) time during the Promotion Period.

**b.** Run or Walk: Once you have synced your device, as outlined in Section 4.a, follow the instructions to run or walk any distance, any speed, any time, and track within your device.

Please consult your doctor before engaging in any exercise or training activity. If you experience a medical emergency, please stop your exercise or training activity, and consult with a medical professional immediately.

Message and data rates apply to use of mobile device. You may be charged by your wireless carrier for participating via mobile device. It is therefore recommended that you consult your wireless carrier's pricing plan before participating via mobile device. Not all mobile devices offer wireless Internet access; and, wireless Internet access may not be available in all areas.

Once you track one (1) run/walk within your device, you will receive one (1) entry into the Sweepstakes. Please note that once your device is synced (as outlined in Section 4.a), you will retroactively earn entries for each day you have completed a walk/run during the Promotion Period, up to one (1) entry into the Sweepstakes per calendar day. <u>Limit</u>: Each entrant may complete this action one (1) time per day during the Promotion Period.

Then, once you complete the following number of runs/walks during the Promotion Period and track within your device, you will receive the indicated number of additional Sweepstakes entries. *Unless otherwise noted*, you may complete one (1) run/walk **per day** during the Promotion Period.

c. Make a Purchase and Upload a Receipt: Make an in-store or online purchase of any pair

of Brooks shoes and/or apparel (at least \$50.00; excluding tax and shipping) ("Qualifying Purchase"). Be sure to keep your receipt. Receipts cannot be given away, bartered, auctioned, sold, or traded and all such receipts may be void. Participation in the Promotion by individuals who do so may be terminated at Sponsor's discretion.

Take an image of your entire receipt. The receipt image must be clear and legible and display all of the following: the purchase date and time, and the Qualifying Purchase(s), the price of the Qualifying Purchase(s), and total amount spent. Receipt image must not be larger than 5MB and may only be one of the following file types: 'jpg', 'jpeg', 'png', 'tiff', 'tif', 'tif', 'bmp'.

Visit the Website and follow the links and instructions to upload your receipt image. Each receipt can only be uploaded once.

You will receive an email once your receipt has been reviewed and approved. The review process will take up to 2-3 days. If your receipt was not approved, you will receive an email communication explaining the reason for rejection. You may upload the receipt again if you are able to cure the issues provided in the email communication. Once your receipt has been approved, you will receive thirty (30) entries into the Sweepstakes. <u>Limit</u>: Each entrant may complete this action one (1) time during the Promotion Period.

d. Then, follow the instructions to either sync your device with Brooks' run data partner, DashLX, or to play without syncing a device, locate and click on the free access link in the footer of the Website.

You will advance to the Instant Win Game page and receive one (1) Instant Win Game play for that day. Once on the Instant Win Game page, follow the links and instructions to play the Instant Win Game. The Instant Win Game results will be instantly displayed. Potential winners of the Instant Win Game will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the Instant Win Game.

<u>Limit</u>: Each entrant may play one (1) time per day during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of plays by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's plays and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, or misdirected registrations, which will be disqualified. In the event of a dispute as to the identity of an entrant, Sponsor and Administrator will rely on the information submitted by the entrant to register for this Instant Win Game. If any additional information provided by entrant is inconsistent with the information provided at registration for this Instant Win Game, Sponsor and/or Administrator may disqualify such entrant and such disqualification may result in the forfeiture of any prizes won. Sponsor, in its discretion, may require additional documentation from entrant to show proof of entrant's identity.

6. Sweepstakes Drawing, Get Warmed Up Sweepstakes Drawing and Instant Win Game: Administrator is an independent judging organization whose decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion.

<u>Sweepstakes</u>: Administrator will randomly select the potential Grand Prize Sweepstakes winner, from all eligible entries on or around January 2, 2025.

<u>Get Warmed Up Sweepstakes</u>: Administrator will randomly select the potential three thousand (3,000) Get Warmed Up Sweepstakes winners, from all eligible entries on or around January 2, 2025.

<u>Instant Win Game</u>: Forty-five (45) (one (1) per calendar day) random, computer-generated winning times, one for each prize listed below, will be generated during the Promotion Period. If you are the first player to play the Instant Win Game at or after one of the randomly generated times, you will be a potential instant winner of the prize indicated.

- 7. ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR OR ADMINISTRATOR, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE PROMOTION.
